STRATTON SCHOOL BOARD MINUTES
DECEMBER 6, 2012

The Stratton School board held its monthly meeting on Thursday, December 6, 2012 at the Stratton Town Office. The meeting was called to order at 7:00 P.M.

ATTENDING: Siobhan Eddy Young,, Director, Thomas Montemagni, Chairman and Lorraine M. Weeks-Newell, Secretary.

The minutes of the November 8, 2012 were read. Siobhan Young made the motion to approve and Thomas Montemagni seconded.

ON GOING BUSINESS:

As was reported in the November 2012 minutes, the Board made modifications to the Stratton Residency Policy. The modifications were made and the revised document posted appropriately by the Town Clerk in accordance with the statutes. At the December 2012 meeting, the Board discussed adding the following, "It is required that in the event there are any changes to either residency or school attending that the parent/guardian contact the Stratton Town Office immediately. Siobhan Young made the motion to make the addition to the Residency Policy with Thomas Montemagni seconding. The revised policy will be posted appropriately by the Town Clerk. The Board will vote to approve the revised Residency Policy at the January 2013 meeting.

Laura Hawksley, Town Treasurer, mailed a second transportation form for completion to a family eligible for busing. The form was not returned and the student has not been riding the bus.
